BUDGET HIGHLIGHTS

This year has brought about many challenges but in the process has shown us just how strong we are as a district and as a community. Our budget was designed to allow us to navigate the unexpected and because of this the district was able to provide the necessary precautions all while having the students in-person learning for the majority school year.

Last year the district adjusted its tax levy to a **0% increase** after recognizing the savings from students being home the last few months of the school year.

This year the proposed **2.67% increase** in the budget includes:


- * Maintaining all current programming for students.
- * Maintaining current levels of staffing needed to meet all our students needs.
- * Necessary campus maintenance and temporary repairs.
- * Increases in contractual costs.
- * Maintaining current levels of Covid-19 precautions.

The tax levy limit this year for the Town of Webb UFSD is **1.61%** which the district is proposing to fully utilize for the 2021-2022 budget. The anticipated and proposed per \$1,000 tax rate change of **\$0.05** is based on this years total assessment. Tax rates are finalized annually in August when new total assessment numbers are provided to us.
