## The following propositions will appear on the May 16, 2023 ballot:

#### Proposition #1: 2023-24 Budget

Should the Board of Education be authorized to spend \$11,202,845 for the 2023-2024 school year, and to levy taxes on properties with the Town of Webb UFSD to offset said expenditures?

Adoption of the budget requires a tax levy increase of 11.44% which exceeds the statutory tax levy increase limit of 3.14% for this school fiscal year and therefore exceeds the state tax cap and must be approved by sixty percent of the qualified voters present and voting.

#### **Proposition #2: Board of Education Seat**

The candidate (s) for the remainder of one (1) five-year term commencing after the annual meeting on July 1, 2023, until June 30, 2028 on the Board of Education Vote for one (1) Candidate:

### **Proposition #3: Increase Funding for Old Forge Library**

Should the Board of Education of the Town of Webb UFSD be authorized to increase the annual levy of taxes upon the real property of the district to meet the annual operating cost of the Old Forge Library by an amount of \$20,000 for a total annual appropriation of \$190,000, to be paid to the Trustees of said library?

## **Proposition #4: Increase Funding for Woodgate Library**

Should the Board of Education of the Town of Webb UFSD be authorized to increase the annual levy of taxes upon the real property of the district to meet the annual operating cost of the Woodgate Library by an amount of \$25,000 for a total annual appropriation of \$75,075, to be paid to the Trustees of said library?

# **BUDGET/DISTRICT HIGHLIGHTS**

- The **proposed budget maintains all current programming** and the current level of staffing to best meet the needs of our students while offering them the comprehensive educational experience they deserve.
- The Town of Webb UFSD is working on a required mascot change to meet the directives of the New York State Education Department. We must have a Board commitment to make a change by the end of the current school year. This is another unfunded mandate that will be expensive to comply with. We will need to replace all imaging around the building, on all media sources, and on all uniforms. We have offered opportunities for all stakeholders to be involved in the process of choosing a new mascot and will further engage them as a new image is chosen for the successor to our Eskimo.

#### Tax Levy Limit 3.14% (Consumer Price Index reported on Property Tax Report Card is 8.0%)

- If the Board of Education proposed putting a budget out to the public at the Tax Levy Limit it would require \$547,711 worth of cuts from the budget. Because the Board of Education hopes to maintain all of the current programming for our students they have decided to put a budget forward to the voters that accomplishes that for our students but requires a 60% majority vote of the public to approve going above the tax levy limit.
- If the budget is not approved as proposed, but rather at the tax levy limit the cuts needed to accomplish the nearly \$550,000 in deficit would have an impact on all areas of the budget. Included in the potential reductions would be the Student Resource Officer (unbudgeted addition for the 2022-2023 school year), teaching staff, elective offerings, advanced placement course offerings, modified sports, non-league competition, support staff and maintenance, administrative staff, and bussing. A contingency budget would yield further reductions from the above stated list.
- We have been relying on our fund balance to balance the budget and keep the tax rate stable for years. We have now
  spent down our fund balance, especially after COVID, by being able to accomplish the projects that had been planned
  with funds encumbered for them from previous budgets.

#### For Comparison:

- The July 1, 2018 school tax levy was \$6,176,000; proposed tax levy on July 1, 2023 in this budget is \$7,354,399; using the federal CPI Inflation Calculator the 2018 tax levy would equal \$7,372,792.08 in today's dollars (as of February 2022) meaning our proposal doesn't even keep up with CPI (Consumer Price Index) over the extended period of time.
- The average New York State school tax per \$1,000 of assessed value was \$16.40 per \$1,000 in 2021; this proposal projects the rate to be \$3.84/\$4.06 per \$1,000 depending on your address. The Town of Webb UFSD would still be listed in the lowest 15 school tax rates in the state of over 700 school districts. Many of those below us are either non-functioning or are a district that has limited grade levels that it services.

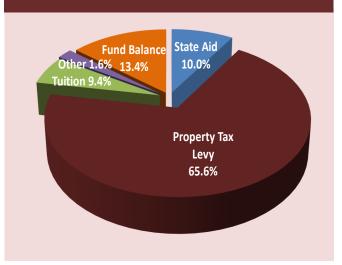
